Annual meeting: 40 days from October 7, 2020 is Monday, November 16, 2020. Hosting virtual Annual Meeting: MO & CO

SECTION 1. Annual Meeting. The annual meeting of the club shall be held between the **1st day of September** and the **31st of December** in conjunction with the club's Annual Specialty Show if possible, at a place, date and hour designated by the board of directors. The board will request that the voting membership submit any matters that they wish to be included on the agenda at least forty (40) days prior to the date of the meeting. *Then the secretary sends the written notice by mail or email announcing the meeting to each voting member in good standing at least thirty (30) days prior to the date of the meeting. A notice about the general nature of a matter must be given in order for that matter to be voted upon at the annual meeting. No vote can be taken on a matter for which there was no notice. The quorum for the annual meeting shall be 10% of the voting members in good standing and at least one board member must be in attendance. It must be confirmed that a board member will be in attendance prior to scheduling the meeting and Annual Specialty Show. A favorable vote of 2/3 of the voting members present at the meeting is required to pass a measure up for consideration. If a quorum is not present at the annual meeting the question will go to the entire voting membership for a vote either by mail-in ballot or by electronic means. Refer to Article IV, Sections 2 and 4(d) for voting procedures.*

Secretary will send out a notice to the membership via email on *Friday, October 9,* **2020**, In accordance with the RTCA By-Laws Article 2 Section 1: The Board requests that any voting member submit any matter or issue to be considered for the Annual Meeting Agenda. It must be sent to the secretary by Wed, November 19, 2020, 8:00 PM MST

Colorado State generally permits corporations, associations, and nonprofits to conduct remote and virtual

meetings. Remote meetings contingent on an organizations articles of incorporation, charter, bylaws.

<u>Corporations</u> (2) Unless otherwise provided in the bylaws, the board of directors may permit any director to participate in a regular or special meeting by, or conduct the meeting through the use of, any means of communication by which all directors participating may hear each other during the meeting. A director participating in a meeting by this means is deemed to be present in person at the meeting.

CO Rev Stat § 7-128-201 (2016)

<u>Nonprofits</u> (2) Unless otherwise provided in the bylaws, the board of directors may permit any director to participate in a regular or special meeting by, or conduct the meeting through the use of, any means of communication by which all directors participating may hear each other during the meeting. A director participating in a meeting by this means is deemed to be present in person at the meeting.
