# **Pedigree Committee:**

Discussion on how breeders are getting non-standard Rat Terriers registered with AKC.

AKC allowing code (000) to be used for coat patterns and colors - Merle and Brindle specifically; this

does not comply with the breed standard.

Breeder has contacted CM numerous occasions to get Certified Pedigrees and has provided the information on how they are getting the non-standard dogs registered and accepted.

RTCA – The Parent Breed Club must push the issue; non-standard dogs got in under false pretenses, Breeder is flaunting the fact they got in under false pretenses.

CM sent correspondence to JB to be put in Policy & Procedures.

RTCA & Pedigree Committee needs to file a complaint with AKC stating:

- the Parent Club Breed Standard must be respected,
- stop allowing unauthorized code (000) to be used and accepted for coat patterns and colors.
- How can we prevent what is currently happening; these dogs do not conform to our standard; we do not believe they are pure bred rat terriers.
- Breeders' original registration that let the merle in, is deemed invalid, and invalidate all the progeny. Falsely registered, registration to be pulled.

If AKC state there is nothing that can be done, CH will pull the research and information from a previous breed incidence, will find out how the other breed filed complaint.
